<b>Duties and Responsibilities</b>	<ul style="list-style-type: none"> <li>• Handle a diverse caseload on behalf of low-income tenants, including eviction defense, discrimination, habitability, subsidized housing cases (including Section 8), and other issues arising in landlord/tenant relationships</li> <li>• Supervise staff attorneys, paralegals, and administrative staff to ensure high-quality legal services are provided to PLC's clients</li> <li>• Oversee volunteers through CLE training, technical support and general supervision at clinics and in casework</li> <li>• Investigate clients' cases, including inspection of housing units and obtaining and reviewing documents and records from government agencies</li> <li>• Represent PLC at networking and community outreach events (when possible)</li> <li>• Full time position with occasional evening and weekend work required</li> <li>• Other duties as assigned</li> </ul>
